Our free Will-writing service

How you can
make a lasting
difference

We understand that the decision to write a Will can be a sensitive matter and one not taken lightly. But it would be wonderful if you could just take a few minutes to read on, before deciding if this is something you can do. You could help us to change the lives of CLL patients.

CLL Support is a member of The National Free Wills Network, which gives us the opportunity to offer a limited number of valid 'simple' Wills (or mirror Wills for a couple) **entirely free of charge** and written by a solicitor local to you. There is no obligation whatsoever to include a gift to CLL Support in your Will, but we sincerely hope that you might consider doing so.





How does it work?

1. You tell us you are interested in using this service.
2. We refer your details to The National Free Wills Network.
Your details are not shared with anyone else and the Network will only contact you to provide the service, never for marketing.
3. The Network send you a list of your nearest participating solicitors and a voucher to take to your appointment.
4. You meet with the solicitor at an office local to you, to discuss your wishes and prepare your Will in the usual way. Most Wills are completely covered by the free Will service. If your Will is more complex, your solicitor will advise you of this, giving you the option to continue and pay the difference if you wish.
5. Once you have made your Will, the Network tells us if your Will includes a gift to CLL Support, so that we can write to thank you.

Your questions answered

Why do I need a Will?

Making your Will is the best way to make sure your loved ones will be provided for. If you do not leave a Will, the state will distribute whatever you leave according to certain rules. This may mean that your loved ones may not receive what you would like them to.

It is also a chance to express your values by remembering a charity. A valid Will states your wishes clearly and avoids confusion or further distress for your loved ones in the future.

Why is CLL Support offering free Wills for our supporters?

The gifts we receive in Wills is vital to our work. We rely on fundraising from our supporters to help us tackle the problems faced by CLL and SLL patients. We could not exist without this help. Many people put off making a Will because of the cost and time involved. Our free Will service makes it quicker and easier for supporters to put their plans in place.

There is no obligation whatsoever to include a gift, but we hope you may feel able to consider it.

If it's free, who pays for it?

The cost is covered by CLL Support. It is a heavily discounted cost and our hope is that legacies received will be far more than the cost of the Will.

Do I have to give a gift to CLL Support in my Will?

No. It is our hope that supporters who know our work and share our mission to help CLL and SLL patients, may take a moment to consider us when making their Will. However, there is no obligation to do so.
